Town Parks

Conservancy users must be mindful and take precautions when utilizing this multi-recreational area. Sherman Creek Park, located at west Vine St, is popular to nearby residents for its location and beauty. Campfires in the fire ring at Sherman Creek Park must not be left unattended and Township fire should be contacted to ensure permission at townshipfire.org or (715)834-6868. Please be respectful of our Town Parks, if you carry in you must carry out to help keep our parks safe and clean! Please notify the Sherriff's Dept of any unusual activity.

Township Fire Burning

To comply with the social distancing mandate and to minimize the exposure of our firefighters to the SARS-Cov2 (COVID-19) virus, the Township Fire Department in conjunction with the Wisconsin Department of Natural Resources has suspended all burning permits until further notice. Therefore, all burning of debris in barrels, piles on the ground and grass or wooded areas is prohibited at this time. Campfires and cooking fires are allowed. Please note that a fire in a campfire ring or fire pit with the intent to eliminate debris requires a burning permit. Roasting hotdogs or marshmallows over a debris fire does not make it a cooking fire; it's still a debris fire which requires a burning permit.

Let us begin the discussion about outdoor burning with the statement "Open burning, outdoor burning and refuse burning are prohibited in the Town unless the burning is specifically permitted by Township Fire Department".

In general, one may burn brush, leaves, pine needles, grass, clean wood, unrecyclable paper and cardboard, with a burning permit, during the hours of 6 PM to Midnight Monday through Friday and 8 AM to Midnight on Saturday. There is no burning on Sundays and Legal holidays. A competent person, 18 years of age or older must be in attendance of the fire until it is completely out (cold).

All piles of materials to be burned shall be sized appropriately so that the fire will be completely out by midnight. It is best to make several small piles rather than one large pile.

Burn Barrels are a safe means of disposing of brush, leaves, pine needles, grass, clean wood, unrecyclable paper, and unrecyclable cardboard (legal materials). Properly maintained, this control structure will minimize the risk of a fire getting out of control. Burning permits are not required when burning legal materials in a properly maintained burn barrel between the hours of 6 PM to Midnight Monday through Friday and 8 AM to Midnight on Saturday (except legal holidays). A competent person, 18 years of age or older must be in attendance of the fire until it is completely out (cold). A burn barrel that is not properly maintained, is considered open burning, and requires a burning permit. Burn barrels may never be used to burn trash or garbage.

Materials that may never be burned include: Rubbish or garbage including but not limited to food wastes, food wraps, packaging, animal carcasses, animal waste, paint or painted materials, furniture, composite shingles, construction or demolition debris or other household or business wastes. Asphalt and products containing asphalt. Treated or painted wood including but not limited to plywood, composite wood products or other wood products that are painted, varnished or treated with preservatives. Any plastic material including but not limited to nylon, PVC, ABS, polystyrene or urethane foam, and synthetic fabrics, plastic films and plastic containers. Rubber including tires and synthetic rubber-like products.

When the fire danger is posted as EXTREME and/or a **Red Flag Warning** has been issued by the National Weather Service, ALL outdoor burning is prohibited (including camp/cooking fires). During a red flag warning, the use of outdoor charcoal grills, smoking, chainsaws, off-road vehicles, or other small engine powered devices should be suspended.

One may have a campfire or cooking fire without the need of burning permit. "Campfire" means a small outdoor fire less than five feet (5') in diameter, intended for recreation, cooking or warming the body, not including a fire intended for disposal of waste wood or refuse. Wood used in a campfire shall be cut, split, trimmed, and sized appropriately for a small campfire and the fire shall be confined by a control device or structure such as a barrel, fire ring or fire pit.

Please be informed that anyone who starts or uses an outdoor fire shall be liable to the Township Fire Department for all fire suppression costs if the fire is in violation of law or it endangers property of others. Fines for unlawful burning start at \$326.50 per violation. Fire suppression costs are based on the number of fire apparatus and fire fighters used to extinguish the fire. Depending on the size of the fire, these costs can total in the thousands of dollars.

Town Road right-of-way

As a reminder, Town road right-of-way (ROW) as defined in State Statutes 82.18 is 66', or 33' each side of the center line of any town road. Road maintenance in the Town of Union is priority and we are proud to be able to maintain our roads as needed, as we know town residents take pride in their property as well. We appreciate when residents maintain the right-of-way adjacent to their property. However, any altering is non-permittable by residents. ROW maintenance such as snow plowing, mowing, tree trimming and or the removal of any natural or man-made objects in the ROW is within the Town's legal right to remove. Our local Township Fire Department maintains annual brush cutting, ditch mowing and tree trimming. Please do not plant trees, perform any landscaping, install fencing, lawn markers or sprinklers in the ROW as the Town is not responsible for any damage that may occur and may remove at the expense of the property owner. Large items in the road right-of-way can present a direct hazard and impede one's vision at intersections which can pose liability issues. Also, please remember to never blow lawn clippings, pine needles or leaves into the road. This is a serious hazard for any motor bike potentially causing motorists tires to lose traction and control. Let us make sure our Town Roads are safe!

Address Markers

Our local Township Fire Dept (TFD), Emergency Medical Services (EMS) personnel and ambulance service use your address marker to quickly locate the correct address in the event of an emergency. It is in your best interest to keep your address marker upright, at the end of your driveway and clear of all obstructions for TFD to identify quickly. If your marker becomes broken

Local Road Construction

Transfer Station updates

Transfer Station hours are now Wednesday 1:00-5:30 & Saturday 9:00-5:30. The green Town of Union bags can be purchased at the Town Hall, Transfer Station or Holiday Gas Station located at 6123 Truax Ln., next to McDonald's off 312. A roll of 10 bags cost \$20. Recently the Town Board voted to reduce the charge of the 33-gallon black trash bag from \$5 to \$3, to avoid those having to re-bag their trash. Please continue to save your aluminum to support our local Township Fire Station, drop off your recyclable aluminum at the Union Transfer Station or Township Fire Station at 5311 W. Cameron St.
