Eau Claire County adopted title 18 on 07/18/2023. Town of Union adopted Eau Claire County Zoning in 1998 and has one year to adopt Title 18.

Visit Eau Claire:

A. Executive Director Report/Benny Anderson was in attendance. Benny Anderson handed out report. Visit Eau Claire is waiting for 3rd quarter room tax reports before giving staff board report. Town of Union still has one hotel/motel that owes room tax for 1st quarter. Events that will be coming to Eau Claire are Snow Shoeing event, Curling Club, and Group Glo (Travel writers for fall & winter). Visit Eau Claire is looking for grants to help Town of Union Conservancy and Silver Mine Ski Hill.

Roads:

- A. County Line Road; Updated design cost: Dennis Mack from Cedar Corp. was in attendance and mentioned that the initial estimate was 2.2million. Have done some cost cutting and now estimate from 1.89 to 1.9million for this project. Grant applied for this project is around 1.5million anything above this Town of Union is responsible for. Still have to meet with Haas Sons and Menards
- B. 2024 Road Projects: Received 50/50 Road Grant, about \$34,000.00.Truax Road by McDonalds needs repair, will chip seal to hotel.Local discretion Grant money will be used for this project.
- C. Railroad Crossing complaints in area/Town of Elk Mound: Eau Claire Grow contacted Town to see if they were aware of repairs Railroad did to their crossings. Town of Union was not aware of any repairs/changes made but knows of issues. Railroad crossings that need improvements are Kane Road, Vollendorf, and Elk Creek by Hwy. 12
