- A. Executive Director Report/Benny Anderson was not in attendance. No report was handed out.

Park Commission:

A. Barb Kleist was in attendance to give December 6th meeting update. Park Commission received a request from Erik Anderson to put trail cameras up in Sherman Creek Park, he is interested in seeing what wildlife is living in the park. Pleasant Hill Go Getters 4-H Club nominated the Town of Union for partnership. Nomination was for usage of Town Hall for meetings and for their community service projects.

Members of Park Commission cleaned out the fire pit at Sherman Creek Park.

The Park Commission is seeking a contractor to complete the updates to the Pavilion at the

Conservancy.

Park Commission received a donation of \$760.00 from a young man. This young man was part of the vandalism to the grills in the park and wanted to give back to the park Commission.

Fire Station #3:

- A. Dave Kleist November run updates: Another structure fire in Pleasant Valley. Lots of crashes. One illegal burn, neighbor was burning materials for his neighbor and was not aware of burning permit.
- B. Address marker update: Dave Kleist has been replacing address markers and mentioned that a lot of markers are actually missing. Will need to reassess again in the Spring.

Roads:

Need to put up "No Parking" signs. Signage will say "No Parking. Violators will be towed away at owners expense."
