ORDINANCE NO: 2011-__-__

THE TOWN BOARD OF THE TOWN OF UNION DOES ORDAIN AS FOLLOWS:

Section **1-6.0210** of the Municipal Code of the Town of Union is hereby repealed and recreated to read as follows:

1-6.0215 BOUNDARIES. Ward boundaries are established as follows, and may be updated from time to time to reflect attachments, annexations or consolidations.

- WARD 1: Beginning at the Northwest corner of the Town; thence East along the North line of the Town to the Northeast Corner of the Town and the City Limits of the of the City of Eau Claire (City Limits); thence along the common boundary of the Town and the City to its intersection with West Folsom St. and North Town Hall Road; thence South on North Town Hall Road to its intersection with West Cameron St.; thence East on West Cameron St. to its intersection with Kane Rd.; thence South on Kane Road to its intersection with Curvue Rd.; thence Westerly on Curvue Rd. to its intersection with North Valley Rd.; thence North along North Valley Rd. to its intersection with West Cameron St.; thence West on West Cameron St. to the West line of the Town; thence North on the West line of the Town to the Place of beginning.
- WARD 2: Beginning where the center line of Crescent Ave. crosses the center line of Interstate Highway 94; Thence Southeasterly along the center line of Interstate Highway 94 to the Chippewa River; thence Westerly along the Chippewa River to the West line of the Town; thence North along the West line of the Town to West Cameron St.; thence East on West Cameron St. to its intersection with North Valley Rd.; thence South along North Valley Rd. to its intersection with Curvue Rd.; thence Easterly on Curvue Rd. to its intersection with Crescent Ave.; thence Easterly on Crescent Ave. to the point of beginning.
- WARD 3: Beginning at the intersection of Kane Road and West Cameron St.; thence South on Kane Road to its intersection with Curvue Rd.; thence Easterly on Curvue Rd. to its intersection with Crescent Ave.; thence Easterly on Crescent Ave. to the City Limits; thence Northerly and then generally counter-clockwise along the common boundary of the Town and the City to the point where the East boundary line of Interstate Highway 94 intersects the center line of West Cameron St.; thence West on West Cameron St. to the point of beginning.
- WARD 4: Beginning at the intersection of North Town Hall Rd. and West Cameron St.; thence North on North Town Hall Rd. to West Folsom St.; thence beginning Easterly and continuing in a generally clockwise direction along the common boundary of the Town and the City to the point where the East boundary line of Interstate Highway 94 intersects the center line of West Cameron St.; thence West on

West Cameron St. to the point of beginning.

The Clerk shall maintain a map showing the ward boundaries, and shall attach to said map a list of the block numbers used by the U.S. bureau of the census that are wholly or partly contained within each ward, with any block numbers partly contained within a ward identified.

[This section not published or codified] All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

[This section not published or codified] The provisions of this Ordinance are severable. If any part or provision of any section, clause, or provision hereof is invalid or if its application to any person or circumstance is invalid, such invalidity shall not affect other provisions or applications which can be given effect without the invalid provision or application.
